

Big Tax Cut Causes Sharp Drop in State Revenue Collections

Legislation the Republican-controlled Missouri General Assembly passed in May to eliminate state taxes on capital tax is causing general revenue collections for the current fiscal year to crater – just as Democratic lawmakers had predicted. As a result, state budget officials now expect the state to collect about \$410 million less than originally expected for the current fiscal year, which runs through June 30.

The original consensus revenue estimate for FY 2026 anticipated 1.6 percent general revenue growth over the prior year and total collections of \$13.56 billion. The revised FY 2026 CRE Gov. Mike Kehoe announced yesterday anticipates a 2.1 percent decline in general revenue, with expected collections of \$13.15 billion. Budget officials in the governor's office and majority party in the legislature typically agree to a CRE ahead of the upcoming budget cycle to ensure all sides are working from the same numbers.

With such a significant drop in general revenue collections that lawmakers didn't account for when crafting the current state budget this spring, it could force Kehoe, a Republican, to unilaterally institute mid-year spending cuts. Although he hasn't yet announced any such plans, they could come when he delivers the annual State of the State address before a joint legislative session on Jan. 13.

Kehoe also will present his proposed state operating budget for FY 2027 at that time. The FY 2027 CRE calls for 3.8 percent growth over the revised FY 2026 estimate. Although that seems robust at a glance, that's only because its being calculated off a sharply reduced base. While the \$13.65 billion in revenue for FY 2027 is \$500 million higher than the revised FY 2026 CRE, it's just \$90 million more than what the state originally expected to collect for the year.

Despite the collapsing state revenues, Kehoe appears undeterred in his plan to ask lawmakers to phase out state income taxes, which currently account for about 71 percent of state revenue collections. Kehoe has not specified how the state would replace such a huge amount of revenue, but the only viable option would be a massive expansion of state sales taxes. That not only would increase prices but shift the tax burden from wealthy to less affluent taxpayers.

Columbia District Sues to Block Expansion of Charter Schools

The Columbia Public Schools filed a lawsuit on Dec. 15 challenging the constitutionality of a 2024 state law authorizing outside groups to establish charter schools in Boone County. The

legal action, filed in Cole County Circuit Court, comes as a Kansas City-based charter school operator seeking to open one in Columbia.

Charter schools are public schools that operate free of many of the state education regulations that apply to traditional public schools' districts. Since being authorized by state law in the late 1990s, charter schools had been limited to the Kansas City and St. Louis City districts or school systems that had lost their state accreditation.

However, a provision of Senate Bill 727, a massive omnibus education measure enacted in 2024, expanded charters to Boone County – but no other Missouri counties. Since school systems in the county are neither large urban districts nor academically deficient, Columbia's lawsuit alleges the provision violates the Missouri Constitution's prohibition against "special laws" that apply to one or a few jurisdictions while excluding similar jurisdictions without a rational basis.

The reason for expanding charters only to Boone County appears to be that then-Senate President Pro Tem Caleb Rowden, R-Columbia, wanted them authorized in his home county. The political desire of one lawmaker, the lawsuit notes, doesn't provide the rational basis for a special law.

In addition, the lawsuit cites a constitutional provision requiring a proposed special law to be posted in the affected jurisdiction at least 30 days prior to the bill being filed. No such notice regarding the charter school law was ever posted in Boone County.

Because charter schools are funded by siphoning tax revenue from their local public school district, Columbia alleges the district would suffer substantial financial harm should a charter be approved to operate locally. The district is asking the judge to declare the charter expansion provision of SB 727 unconstitutional and block the Missouri State Board of Education from approving the application for a charter school in Columbia.

No hearing had yet been arranged in the matter as of Dec. 18. The case is Columbia 93 School District, aka Columbia Public Schools, et al., v. State of Missouri, et al.

Judge Puts Ruling on Referendum Petition Signatures on Hold

A Cole County judge will indefinitely postpone ruling on whether local election officials must count about one-third of the more than 305,000 signatures submitted on a referendum petition to force a statewide vote on whether Missouri's newly re-gerrymandered congressional districts should take effect.

In apparent violation of the Missouri Constitution, Secretary of State Hoskins, a Republican, unilaterally declared he won't accept signatures collected before he certified the petition on Oct. 14, even though the 90-day constitutional window for collecting signatures opened Sept. 12 – the final day of the special legislative session at which the congressional redistricting measure, House Bill 1, was enacted. Hoskins' claim affects about 103,000 signatures.

People Not Politicians, the campaign group responsible for the referendum petition, sued to force Hoskins to accept all signatures from registered Missouri voters gathered during the entire constitutional collection period. After several delays, a trial in the case was held on Dec. 8, just days before the deadline for turning in signatures.

While a quick ruling had been expected, Circuit Judge Christopher Limbaugh, a Republican, instead issued an order Dec. 12 delaying final action in the case to see if the HB 1 referendum qualifies for the Nov. 3 ballot based on verification of the remaining 202,000 signatures. Roughly 110,000 valid signatures are needed.

“Conceivably, this could be enough signatures to place the referendum on the ballot thereby mooting the issues presented in the case at bar,” Limbaugh wrote. “Therefore, the court will hold this case in abeyance until the requisite number of signatures have been certified or up until enough signatures have been rejected so as to prevent plaintiffs’ referendum from appearing on the ballot.”

Since HB 1 was constitutionally suspended from taking effect pending the signature verification process, Limbaugh’s delay should have no immediate impact. However, Hoskins has falsely claimed that, despite the filing of the referendum petitions, the new congressional districts took effect Dec. 11 and should be used when candidate filing for the Aug. 4 party primaries opens Feb. 24. A lawsuit challenging that declaration is expected if steps are taken to implement HB 1.

The Republican-controlled General Assembly enacted the unprecedented, off-cycle redistricting bill on orders from President Donald Trump, who commanded GOP-led states to engage in an unscheduled round of redistricting in a desperate bid to help the party retain its bare majority in the U.S. House of Representatives in the 2026 midterm elections.

HB 1 seeks to carve up the heavily Democratic 5th District based in Kansas City to give Republicans an advantage in seven of Missouri’s eight congressional districts. In addition to the referendum petition to block HB 1 from taking effect, several lawsuits have been filed challenging the bill’s constitutionality. The case relating to the petition counts is *People Not Politicians, et al., v. Missouri Secretary of State Denny Hoskins*.

Supreme Court Denies State's Appeal in Abortion Case

Without comment, the Missouri Supreme Court on Dec. 16 denied Attorney General Catherine Hanaway's appeal of lower court rulings indefinitely blocking enforcement of several anti-abortion laws. As a result, the laws will remain on hold until a Jackson County Circuit Court judge issues a final decision in the case, which is scheduled for trial in January.

Judge Jerri Zhang put the laws on hold earlier this year, finding plaintiffs are likely to prevail on their claims that the laws violate protections for reproductive rights Missouri voters added to the state constitution last year. She also held plaintiffs will suffer immediate harm if the laws remain in effect while the litigation is pending. The Missouri Court of Appeals Western District unanimously upheld Zhang's ruling in October.

Planned Parenthood, Missouri's remaining abortion provider, sued the state late last year, alleging that the new constitutional protections rendered several existing statutory restrictions unconstitutional. The laws Zhang has blocked include a mandatory 72-hour abortion waiting period and several strict licensing requirements that apply to abortion clinics but no other outpatient surgical clinics.

The Supreme Court let the lower court decisions stand in an unsigned order. The underlying case is *Comprehensive Health of Planned Parenthood Great Plains v. State of Missouri*.

Kansas City Area Food Pantries



Food pantries and food banks play a key role in addressing food insecurity in the state of Missouri. Food insecurity is described by the United States Department of Agriculture as “access by all people at all times to enough food for an active, healthy life.”

According to reports from the University of Missouri, almost 780,000 Missourians are food insecure while an additional 356,000 are experiencing hunger or very low food insecurity. Reports from Feeding Missouri states that there are 6 major food banks in our state that distributes over 120 million pounds of food every year through over 1,500 community feeding programs located across the state. As mentioned, food banks and pantries play a major role in reducing immediate hunger and food insecurity – but they alone cannot solve the ever-increasing problem of hunger. This will take a collaborative effort of individuals, private, nonprofit, and public sectors. In my view, there needs to be major policy responses that address the root causes of food insecurity.
