Kehoe Plan Would Shift Tax Burden to Working Missourians



Gov. Mike Kehoe on Nov. 11 said he intends to ask the Republican-controlled Missouri General Assembly to put a proposed constitutional amendment on the statewide ballot next year to authorize the gradual elimination of state income taxes, which currently provide more than 70 percent of the state's annual general revenue collections.

Lawmakers are expected to consider this proposal to begin phasing out the state's individual income tax next year. The plan, still in development, would address the state's 4.7% income tax, which generates roughly \$10 billion annually, about 63% of general revenue. State leaders are exploring ways to offset that revenue through other sources, such as sales and corporate taxes, while aiming to minimize the impact on Missourians.

The proposal would require voter approval, consistent with the state constitution's requirements for citizen input on tax changes. House leaders have indicated the plan could be phased in over a decade to avoid fiscal disruption. Previous efforts to reduce or eliminate the income tax have raised concerns about funding for schools, roads, public safety, and state employee salaries, as well as the potential impact of replacing revenue through service taxes.

Lawmakers are set to begin filing legislation for the 2026 session on December 1, with the session officially starting January 7. If approved by the General Assembly, any measure would go before voters in the 2026 election.

State Treasurer Sues Revenue Department Over Tax Records



State Treasurer Scott Fitzpatrick sued the Missouri Department of Revenue and its director on Nov. 7, accusing agency officials of unlawfully failing to comply with subpoenas for tax records issued in connection with two audits. The lawsuit, filed in Cole County Circuit Court, asks for a judicial order compelled the department to provide the requested records.

One audit involves the Missouri Works Program, which allows qualified employers to keep a portion of the state taxes withheld from workers' paychecks in exchange for creating or retaining jobs. Fitzpatrick's office sought certain tax records as part of a statutorily mandated audit of the program and eventually resorted to issuing a subpoena for them after the department refused.

The revenue department based its refusal on a state law that generally keeps taxpayer information confidential. However, another law grants state auditors' access to any government records deemed necessary to perform their duties. To protect sensitive information, auditors are subject to felony criminal charges if they improperly share confidential information.

The second audit involves so-called "outlawed checks," which is an outstanding check issued by the state that has not been cashed within a year. Once a check is "outlawed," its recipient can still seek payment by filing a statement with the State Treasurer's Office stating the reason why it wasn't cashed and requesting a duplicate check be issued.

According to the lawsuit, the actual amount of money the state has paid in duplicate checks increased approximately 327 percent over a period of six fiscal years, going from \$1.9 million in FY 2019 to more than \$8 million FY 2024. The audit seeks an explanation for this trend, but the revenue department denied auditors access to the relevant records.

As of Nov. 13, the revenue department hadn't yet filed a response to the lawsuit's allegations. The case is Scott Fitzpatrick, Auditor of the State of Missouri, v. Trish Vincent, Director of the Missouri Department of Revenue, et al

Court Hears Arguments Over Missouri Congressional Map Challenge

Attorneys appeared Wednesday in Cole County Circuit Court to debate the legality of Missouri's recently redrawn congressional map, which was passed during a September special session. The case centers on whether the Missouri Constitution allows lawmakers to revise congressional district lines mid-decade, absent new census data.

Challengers argued that the constitution, adopted in 1945, does not grant the General Assembly the power to redraw districts outside the post-census process. Their argument is that the omission of such authority was deliberate and that courts should ensure lawmakers do not exceed their constitutional powers.

State attorneys countered that, because the constitution does not explicitly prohibit mid-decade redistricting, lawmakers retain the authority to adjust districts. They noted that district boundaries are a political question, and courts should avoid intervening unless the constitution expressly forbids legislative action.

Judge Christopher Limbaugh has allowed attorneys ten days to file proposed judgments, with no decision expected until after those filings. The case is one of six pending across Missouri courts, including challenges from the Missouri NAACP and Jackson County regarding the map's legality and the possibility of a public referendum.

The constitutional requirement mandates that congressional districts be redrawn after the census to ensure equal population and compact, continuous territory. The current map was set in 2022 following the 2020 census, and the legal debate now hinges on whether lawmakers may act outside that timeline.

Missouri Submits Rural Health Transformation Plan to CMS

The State of Missouri has submitted its Rural Health Transformation (RHT) plan to the Centers for Medicare & Medicaid Services (CMS), aiming to improve healthcare access, quality, and sustainability in rural communities. Developed collaboratively by the Missouri Department of Social Services (DSS) in partnership with the Departments of Health and Senior Services (DHSS) and Mental Health (DMH), as well as local healthcare stakeholders, the plan seeks to create a coordinated, long-term approach to rural healthcare.

Key components of the RHT plan include improving access by connecting rural providers, pharmacies, public health agencies, and digital health tools through regional networks; expanding availability of primary care, behavioral health, and maternity services while strengthening specialty care via telehealth; and enhancing provider sustainability through local collaboration and incentives tied to improved health outcomes.

The MO HealthNet Division of DSS is leading the application effort, which, if approved, would provide funding through a five-year cooperative agreement. CMS is expected to notify participating states by December 31, 2025. The plan represents a coordinated effort to strengthen Missouri's rural healthcare system for the long term.

Missouri Explores Options for Arrowhead Stadium Amid Chiefs' Future Uncertainty

As the Kansas City Chiefs are considering whether to renovate Arrowhead Stadium or build a new facility, Missouri officials have suggested potential improvements to the current stadium, including the possibility of a retractable roof. The idea, highlighted by state leaders this week, would aim to create an all-weather environment without constructing a full dome.

Missouri has offered incentive packages through the Show-Me Sports Investment Act, which allows the state to contribute up to 50% of the cost of a new stadium or renovations. While any design decisions ultimately rest with the team, state officials have emphasized creative options to enhance the fan experience while preserving Arrowhead's iconic atmosphere.

The Chiefs and Kansas City Royals' potential moves have been the focus of negotiations between Missouri and Kansas, with lawmakers and voters in both states weighing funding and tax incentives. The Chiefs have indicated that renovations to Arrowhead are under consideration if the team remains in Missouri, while the Royals have explored several possible locations in the state.

Honoring Missouri's Veterans and Expanding Opportunities

Veterans Day offers an important reminder of the service and sacrifice of the men and women who have worn our nation's uniform. Across Missouri, communities gathered to recognize those who answered the call to serve—honoring their courage, their families' support, and the example they continue to set for future generations. From local ceremonies and school programs to events at the State Capitol, Missouri joined the nation in expressing gratitude to our veterans and reaffirming our commitment to support them in every stage of life.

The Missouri Department of Economic Development recently opened a public comment period for the Missouri Veterans and Job Opportunity Grant Program, a new initiative designed to encourage businesses to hire veterans and other Missourians who have faced barriers to employment. The program will provide grants to eligible employers and is accepting feedback from the public through December 12, 2025, ahead of its application period opening in January 2026.

Missouri Reports October 2025 General Revenue Collections

The State of Missouri reported net general revenue collections of \$967.1 million for October 2025, an increase of 8.6 percent compared to October 2024, when collections totaled \$890.9 million. Fiscal year-to-date collections for the 2026 fiscal year are \$3.97 billion, up 1.5 percent from \$3.91 billion in the same period last year, according to State Budget Director Dan Haug.

By tax type, individual income tax collections rose 8.2 percent for the month and 4.5 percent for the year. Sales and tax collections increased modestly by 0.7 percent for the month and 1.1 percent for the year. Pass-through entity taxes grew slightly for the month but were down 20.7 percent for the year. Corporate income and franchise taxes declined 6.9 percent for the month and 26.4 percent for the year. Other collections fell 13.9 percent for the month and 9.5 percent for the year, while refunds decreased 30.6 percent for October and 17.3 percent year-to-date.

These figures provide a snapshot of Missouri's revenues and can fluctuate due to various economic factors.

State Supreme Court Hears Voter ID, Registration Cases

The Missouri Supreme Court heard arguments Nov. 19 in two cases challenging portions of a 2022 state law championed by Republicans to restrict voting access. The court will rule in the cases, both brought by the Missouri chapters of the NAACP and League of Women Voters, later.

The first case challenges a provision of House Bill 1878 requiring a government-issued photo ID to vote. HB 1878 marked the third time the Republican-controlled Missouri General Assembly enacted a photo voter ID mandate. After the Supreme Court struck down the first two attempts for violating the voting-rights provision of the state constitution, GOP lawmakers put a constitutional amendment on the 2016 statewide ballot to specifically grant the legislature the authority to enact a voter ID requirement. Voters ratified it with 63 percent support.

Despite that amendment, the plaintiffs contend that since voting is a fundamental right under both the state and federal constitutions, any photo voter ID requirement must still clear the high constitutional bar of addressing a compelling governmental interest, being narrowly tailored to achieve that interest and doing so by the least restrictive means. A blanket photo ID mandate for all voters, they argue, doesn't pass that constitutional standard, known as "strict scrutiny," especially since cases of voter impersonation are extremely rare.

However, a circuit court judge dismissed the case, ruling the individual plaintiffs lacked the legal standing to challenge the photo ID requirement since none of them were at risk of being denied their right to vote because of the law since they all had a valid photo ID. As a result, the photo ID requirement was in effect for both the 2022 and 2024 state elections.

The second case challenges other provisions of HB 1878 that basically sought to outlaw voter registration drives by establishing strict requirements – subject to criminal penalties for

violations – for those seeking to register more than 10 people to vote. A circuit court judge declared those provisions unconstitutional and issued an injunction blocking their enforcement.

The cases are Missouri State Conference of the NAACP, et al. v. State of Missouri, et al., and League of Women Voters of Missouri, et al v. State of Missouri, et al.

Judge Rules Law On ‘Explicit Sexual Material’ Unconstitutional

A Jackson County judge on Nov. 17 ruled unconstitutional a 2022 state law that sought to make it a criminal offense to provide vaguely defined “explicit sexual material” to students, finding it violates both the due process and free speech provisions of Missouri Constitution. The challenged provision was part of wide-ranging legislation relating to judicial proceedings that passed the legislature with just a single dissenting vote.

However, two advocacy groups for librarians took issue with a section of the legislation, Senate Bill 775, that made it a Class A misdemeanor punishable by up to a year in jail and \$2,000 fine for anyone affiliated with a public or private school to provide students with “explicit sexual material.” They alleged the definition of what constitutes such material is so vague and overbroad as to put school librarians at risk of prosecution and imprisonment over legitimate and age-appropriate content choices in violation of their constitutional rights.

Judge J. Dale Youngs agreed and permanently blocked enforcement of that provision. None of the other provisions of SB 775 – including those relating to child sex trafficking, sexual exploitation of a child and orders of protection – were challenged. The state is expected to appeal to Youngs’ ruling to the Missouri Supreme Court. The case is Missouri Association of Librarians, et al., v. Melissa Johnson.

Kansas City Area Food Pantries



Food pantries and food banks play a key role in addressing food insecurity in the state of Missouri. Food insecurity is described by the United States Department of Agriculture as “access by all people at all times to enough food for an active, healthy life.”

According to reports from the University of Missouri, almost 780,000 Missourians are food insecure while an additional 356,000 are experiencing hunger or very low food insecurity. Reports from Feeding Missouri states that there are 6 major food banks in our state that distributes over 120 million pounds of food every year through over 1,500 community feeding programs located across the state. As mentioned, food banks and pantries play a major role in reducing immediate hunger and food insecurity – but they alone cannot solve the ever-increasing problem of hunger. This will take a collaborative effort of individuals, private, nonprofit, and public sectors. In my view, there needs to be major policy responses that address the root causes of food insecurity.
